

TERMS OF USE

PLEASE READ THESE TERMS AND CONDITIONS CAREFULLY BEFORE USING THIS SITE

1. WHAT'S IN THESE TERMS?

1.1 These terms tell you the rules for using our website crminstitute.org (**our site**).

2. WHO WE ARE AND HOW TO CONTACT US

3. BY USING OUR SITE YOU ACCEPT THESE TERMS

3.1 By accessing or using our site, you confirm that you accept these terms of use, our [privacy policy](#) and our [cookie policy](#) and that you agree to comply with them. Please read these terms carefully before accessing or using the information available through our site.

3.2 These terms will constitute a legal agreement between **you** (the user of our site) and us. If you do not agree to these terms, you must not use our site.

4. WE MAY MAKE CHANGES TO THESE TERMS

4.1 We may modify or amend these terms at any time without notice. By using our site you are agreeing to be bound by the current version of these terms.

9.9 Failure to comply with this Clause constitutes a material breach of these terms, and may result in our taking all or any of the following actions:

9.9.1 immediate, temporary or permanent withdrawal of your right to use our site;

- 9.9.2 issue of a warning to you;
- 9.9.3 legal proceedings against you for reimbursement of all costs on an indemnity basis (including, but not limited to, reasonable administrative and legal costs) resulting from the breach;
- 9.9.4 further legal action against you; and/or
- 9.9.5 disclosure of such information to law enforcement authorities as we reasonably feel is necessary or as required by law.

We exclude our liability for all action we may take in response to breaches of these terms. The actions we may take are not limited to those described above, and we may take any other action we reasonably deem appropriate.

- 9.10 Where applicable, we shall deem you liable for the acts or omissions of your directors, officers, employees, contractors, agents or subcontractors in the event of any breach of these terms, whether arising as a matter of contract, tort (including negligence), fraud or otherwise.
